A brief description of the discipline	<p>The purpose of the discipline: the formation of students' medical knowledge, skills and abilities to understand the cosmetic aspects of skin structure and function, skin care rules, etiopathogenetic factors of cosmetic skin defects, methods of their cosmetic correction and prevention.</p> <p>Tasks:</p> <ol style="list-style-type: none"> 1. Study of cosmetic aspects of the structure and functions of the skin, age of the skin, the causes of premature skin aging; 2. Study the rules of care for different skin types; 3. Study of the basics of the etiopathogenesis of the development of cosmetic changes in the skin and its applications; 4. Determination of the basics of etiopathogenesis, clinical picture, diagnosis and principles of treatment of the most common dermatoses of infectious and non-infectious cause, which lead to cosmetic defects of the skin and its applications (seborrhea, acne, rosacea, viral diseases, skin tumors, dyschromia, etc.); 5. Study of aspects of the etiopathogenesis of hair changes, types of alopecia, their diagnosis, principles of medical and cosmetic correction; 6. Study of the application of hardware methods in cosmetology, indications and contraindications to their use. <p>The results of the discipline:</p> <p><i>The student must know:</i></p> <ol style="list-style-type: none"> 1. Cosmetological aspects of the structure and functions of the skin. Causes of cosmetic skin changes. 2. Skin lesions in dermatoses of infectious and non-infectious cause, which lead to cosmetic skin defects. 3. Diseases of the sebaceous glands (seborrhea, acne). Rosacea. 4. Hair diseases (alopecia).
