Bukovinian State Medical University (BSMU) is one of Ukraine's leading medical higher education institutions. To keep our reputation in the system of medical and pharmaceutical education, we train specialists of the future who can fulfil up-to-date requirements.

A clear and transparent strategy, teamwork, as well as consolidation of educational, scientific, treatment and diagnostic activities with the staff potential of our University, will allow achieving the goal in terms of global competition and becoming the best on the educational services market among medical educational establishments both in Ukraine and Europe.

A strategic goal of the program is to ensure the leading position of Bukovinian State Medical University as a cutting-edge and competitive scientific and educational center in the medical education sector.

The aim can be achieved by interacting with regional governing bodies, educational organizations, medical facilities and enterprises using mechanisms for public and private partnership.

INTERNATIONAL RELATIONS



Integration of BSMU into the international system of medical education accreditation of BSMU at international bodies., e.g. ECFMG, European national agencies.

*Implementation of the strategy for the development of BSMU international integration. This will be by incorporation of BSMU into international and bilateral programs focused on medical education, training and research.

*Development of a managerial system for implementation of agreements and contracts with national and international partners in medical education, training and research. We will implement a model including Memorandum of Understanding and a documentation package to facilitate bilateral contracts. This would include objectives in education, exchange and cooperation, with appropriate legal and managerial support. Our team has extensive experience of such contracts in Europe, the USA, the UK, and Middle East/Turkey.

Assurance of stable growth of the BSMU international ranking, e.g., as a medical university and in total university rankings. Examples are Times Higher Education (THE) and QS World University Ranking.

*Development of exchange and training programs. Examples under consideration are VSLO and IFMSA. Our team has a good experience with the IFMSA (International Federation of Medical Students' Association opening doors to top healthcare providers).

*Development of a database of exchange-supporting organizations, and promotion of these opportunities to our students. The goal is to support applications of our students. Examples of the organizations are listed at <https://www.topuniversities.com/student-info/scholarship-advice/medical-scholarships-around-world> . Our team has extensive experience of such programs. Our team has experience of developing common courses including Ukrainian Medical University, Uppsala University, Karolinska Institutet and Qatar University. This experience will be implemented at BSMU.

*Development of a pool of the core curriculum lectures in English. The goal is to make our students familiar with international educational activities. Experience of medical English would allow our students to be well comfortable in international contacts.

*Development of the series of extra-curriculum seminars to familiarize our students with up-to-date developments in medicine. Lecturers will be BSMU and invited experts.

*Development of a program for support of employment opportunities for our students. This program will include national and international components. The national program will include the development of clinical rotations at healthcare entities that could provide potential job opportunities. The international program will include clinical rotations at healthcare entities/hospitals abroad. Examples are rotations offered for the last year students in the USA, Canada or the UK. Our team has extensive experience in the organization of such rotations.

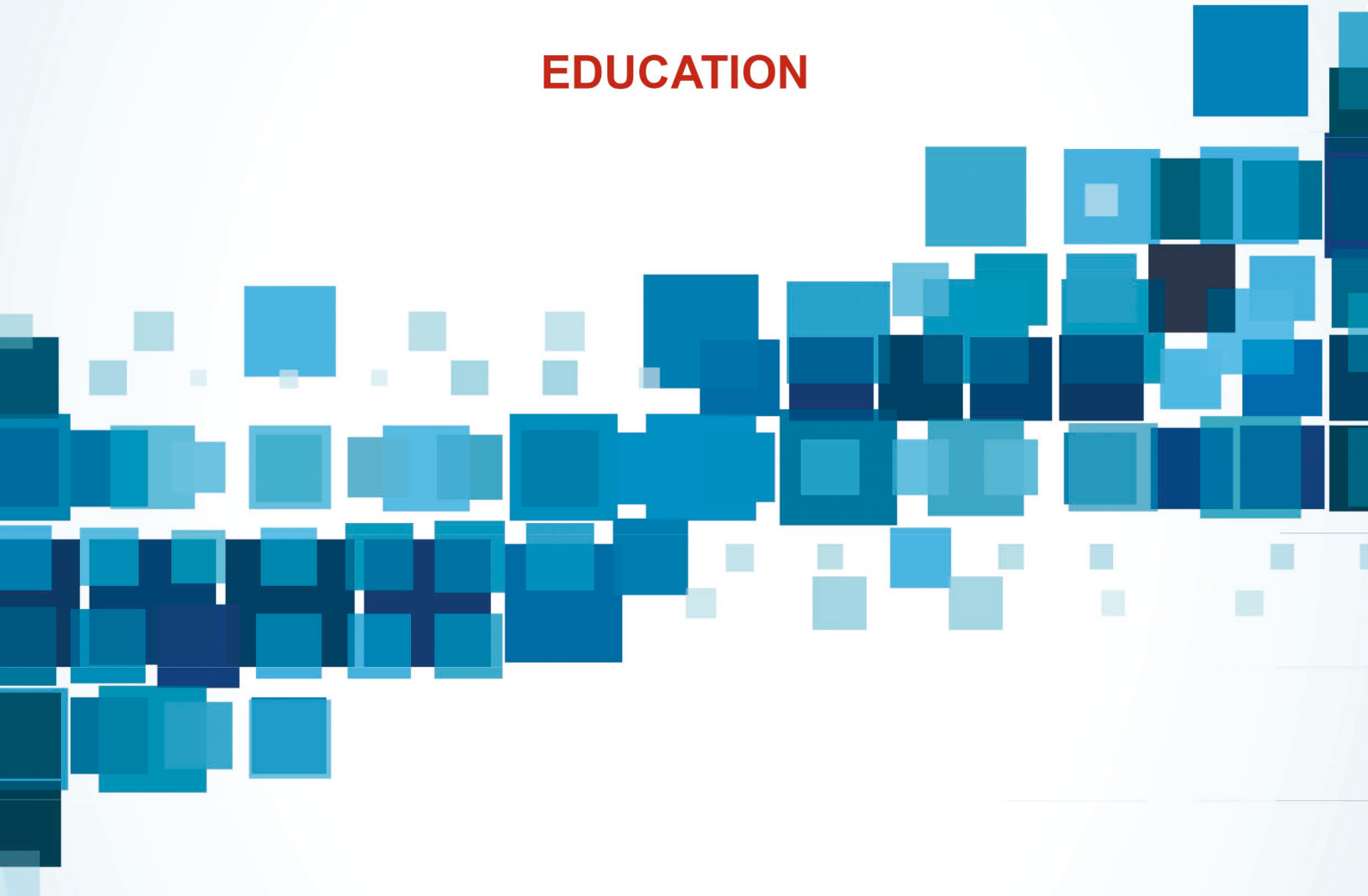
