Summary of the subject: The purpose of teaching discipline «Fundamentals of prevention substance use and abuse» is to study the aetiology, pathogenesis, clinic, diagnosis, treatment, prevention and expertise diseases arising due to the use of psychoactive substances.

The main tasks of teaching elective courses «Fundamentals of prevention substance use and abuse» are:

- identify the causes and patterns of the disease;
- identify the patterns and features of the disease that require special tactics of patient management.

The subject of study of the discipline is the epidemic process, methods of prevention and organization of measures in the occurrence and spread of disorders arising from the use of PS.

Thematic plan of lectures (20 hours):

 Subject and tasks of Addiction. Definition of terms. The modern classification of mental and behavioural disorders due to psychoactive substance use (ICD -10). Classification of psychoactive substances. (2 hours)

- 2. Medical and psychological, social and legal issues use and dependence on psychoactive substances. Psychological mechanisms and manifestations preclinic forms of substance use. (2 hours)
- 3. Psychological and psychopathological mechanisms of dependent behaviour in substance abuse. (2 hours)
- 4. Diagnostic criteria and symptoms of use and dependence on alcohol. Stages of alcoholism. Behavioural, psychological and somato-neurological disorders. (2 hours)
- 5. Diagnostic criteria and symptoms of use and dependence of drug abuse substances. Behavioural, psychological and somato-neurological disorders. (2 hours)

- 2. Psychological mechanisms and manifestations of prenosological forms of psychoactive substance use (2 hours).
- 3. Psychological and psychopathological mechanisms of formation of addictive behaviour in the abuse of PS, its symptoms (4 hours).
- 4. Diagnostic criteria for alcoholism. Stages of dependence formation. Mental and behavioural disorders in patients with alcoholism. Stages of alcoholism (6 hours).
- 5. Criteria for narcotic substances. Classification of addictions. Stages of development and final state in various forms of drug addiction (6 hours).

- 6. Classification of toxicomania. The main criteria of acute and chronic intoxication, post-intoxication, mental, psychological and behavioural disorders in toxic substances addicts (4 hours).
- 7. Treatment and rehabilitation of patients with alcoholism, drug addiction and substance abuse (6 hours).
- 8. The role of the general practitioner in the formation of psycho-hygienic conditions to prevent the use of PS. Building striving to healthy lifestyles (2 hours).
- 9. Forms and methods of primary, secondary and tertiary psychological prevention of psychoactive substances use (2 hours).
- 10. Basic forms and methods of psychocorrection and psychotherapy in narcology (4 hours).

 - 4. Ability to make a differential diagnosis of disorders caused by the use of PS, to determine the tactics of managing a patient with disorders due to the use of PS, to prescribe medication or refer the patient to a narcologist.
 - 5. Ability to diagnose emergencies.
 - 6. Emergency care skills.
 - 7. Ability to keep medical records.
 - 8. Ability to carry out sanitary and hygienic and preventive measures.
